The primary objective of an Intellectual Property Rights is to encourage inventions by promoting their protection and utilization so as to contribute to the development of Industries, which in turn contributes to the promotion of technological innovation and to the transfer and dissemination of technology.

The IPR Cell is created to give a competitive edge to any Institution. The IPR Cell gives the platform to persons over the creations of their minds. They usually give the creator an exclusive right over the use of his/her creation for a certain period of time. The IPR cell shall help the inventor in drafting the patent application/ or any other IPR application and filling out relevant forms. The draft application along with the relevant forms shall be forwarded to the concerned agency/authority by the IPR cell.

The various forms Of Intellectual Property are: 1. Patents, 2. Trademarks, 3. Copyright, 4. Industrial Designs, 5. Geographical Indication, 6. Semiconductor Integrated Circuit's layout – Design and 7. Trade Secrets.
