## OFFICE ORDERS ADMISSION CELL

The **Admission Cell** is dedicated to facilitate the admission process ensuring that every deserving student receives justified opportunities based on their credibility. However, aspirants are required to cater to the eligibility criteria in order to ensure a seamless admission.

The Admission Cell is responsible for the diploma, under graduate and post graduate students admissions in the concerned programs. This cell will also develop contacts with other relevant graduate admissions committees with the goal of identifying potential candidates who would be more appropriate for the BBA, BCA, Diploma, B. Tech and M.Tech Courses. The admissions committee endeavours to identify applicants from various junior colleges. The applicants to be identified by the cell and when possible, invite them to visit the campus. In addition, the admissions cell tracks the success of the admissions process each day during admissions by maintaining a database of pertinent information on the applicants. This cell reviews admission requirements for the program annually. The members of the cell in consultation with HRD prepare attractive brochures, prospectus and handouts for wider publicity. The cell collects the proposals / materials from the departments, committees and lecturers to draft annual plan of activities for the year for publication in the prospectus.

The members of the cell finalize all the matters related to admissions of the students at both UG & PG level. The cell provides all information related to admissions under A Category (Convener Quota) and B Category (Management Quota) to the students and parents. It also provides information on the college website.

The cell issues the notifications for spot admissions under different categories and for admissions under left over/unfilled seat categories as per the guidelines issued by State Government and concerned Competent authority. The cell is responsible to submit the list of admissions made by the college to the concerned competent authorities and get approved. It also organizes activities related to admissions deemed fit by the institute as when decided by the coordinator.
