OFFICE ORDERS

Consequent upon the directions of the Hon'ble Supreme Court of India vide its order dated 16th May, 2007 and in persuasion of the All India Council for Technical Education (AICTE), New Delhi vide its notification No. 37-3/Legal/AICTE/2009 dated 01.07.2009 ordering strict implementation of Rules & Regulations for prevention and prohibition of Ragging in Technical Institutions. The Anti Ragging Committee & Anti Ragging Squad of the Institute is henceforth constituted as under.

The Committee will ensure NO INCIDENTS OF RAGGING in the Institute campus including that of Hostel. The incidents of Ragging, if any, shall be dealt sternly by the Anti Ragging Committee and action as deemed fit as per the law of land shall be initiated by the Committee.

It is further notified that the committee shall willfully study the rules and regulations framed by the AICTE and make themselves aware about the rules & regulations and shall take appropriate measures to prevent the occurrence of ragging as under.

- By pasting the awareness ragging posters in the hostel, dining hall, mess, gym, reception, Institute Library, classrooms and corridors etc.
- By counseling the senior students by the committee and other staff.
- By taking more care/surveillance.
- By putting anti ragging duties round the clock of all the faculty and staff members.
- By taking all incidents of ragging very seriously and initiating disciplinary proceedings/police action i.e. lodging FIR.
- By accompanying the students through Anti Ragging Squad from hostel to the Institute and Institute to the hostel.
- By strict vigilance in hostel, mess, playground, library, canteen, college premises and bus by the Anti Ragging Squad.
